

**ORDINANCE NO. 14 , 2010**

**AN ORDINANCE TO AMEND APPROPRIATIONS FOR  
CURRENT EXPENSES AND OTHER EXPENDITURES OF THE  
CITY OF MONTGOMERY, STATE OF OHIO,  
DURING THE FISCAL YEAR ENDING DECEMBER 31, 2010**

**WHEREAS**, the 2010 Appropriation Ordinance No. 11, 2009 passed December 2, 2009, appropriated a total of \$27,689,229 for the year 2010;

**WHEREAS**, appropriations within certain funds either exceed or are insufficient to meet the obligations of the City;

**NOW THEREFORE, BE IT ORDAINED** by the Council of the City of Montgomery, Ohio, that the attached appropriation ordinance be amended as below:

**SECTION 1.** There be appropriated \$189,000 from the unappropriated balance of the Vintage Club Tax Increment Fund 331 Number to:

**SECTION 2.** There be a reduction of \$8,000,000 in the appropriation balance in the Vintage Club Capital Construction Fund Number 463 from:

**SECTION 3.** There be a reduction of \$10,000 in the appropriation balance in the Environmental Impact Fund Number 226 from:

**SECTION 4.** There be a reduction of \$240,000 in the appropriation balance in the Triangle TIF Fund Number 461 from:

**SECTION 5.** There be a reduction of \$47,750 in the appropriation balance in the FEMA Fire Fund Number 224 from:

**SECTION 6.** There be a reduction of \$1,200 in the appropriation balance in the State Fees Fund Number 601 from:

**SECTION 7.** There be a reduction of \$10,000 in the appropriation balance in the Compensated Absences Leave Fund Number 875 from:

Account Number 875.000.5220      Leave Payout      -      \$10,000
