

**ORDINANCE NO. 18, 2013**

**WHEREAS**, the 2013 Appropriation Ordinance No. 12, 2012 passed December 5, 2012, appropriated a total of \$18,997,892 for the year 2013; and the supplemental Appropriation Ordinance No. 8, 2013, appropriated an additional amount of \$13,042,224; and the supplemental Appropriation Ordinance No. 14, 2013, appropriated an additional amount of \$3,100,000;

**WHEREAS**, appropriations within certain funds either exceed or are insufficient to meet the obligations of the City;

**NOW THEREFORE, BE IT ORDAINED** by the Council of the City of Montgomery, Ohio, that the attached appropriation ordinance be amended as below:

**SECTION 1.** There will be an increase of \$2,237,500 in the appropriation balance of the following accounts of the General Fund 101:

**SECTION 6.** There will be an increase of \$50,000 in the appropriation balance in the Trust Reimbursement Fund 546 to:



**SECTION 7.** There will be an increase of \$1,500 in the appropriation balance in the State Fees Fund 601 to:


Account Number 601.000.5350      Refunds      + \$ 1,500
