**A RESOLUTION AUTHORIZING THE CITY MANAGER TO FILE GRANT APPLICATIONS AND ACCEPT LETTERS OF OFFER FROM THE OHIO DEVELOPMENT SERVICES AGENCY AND JOBS OHIO FOR A ROADWORK DEVELOPMENT (629) GRANT AND THE OHIO DEPARTMENT OF TRANSPORTATION FOR A JOBS AND COMMERCE GRANT FOR THE OHIO NATIONAL FINANCIAL ROADWORK PROJECT FOR ROADWAY IMPROVEMENTS ON PFEIFFER ROAD AND AUTHORIZING THE CITY MANAGER TO EXECUTE ALL CONTRACTS AND OTHER DOCUMENTS**

**WHEREAS**, street and road repairs are a priority for the City of Montgomery; and

**WHEREAS**, the City of Montgomery will, under the terms of a Letter of Offer from the Ohio Development Services Agency and JobsOhio, apply for a \$250,000 Roadwork Development (629) Grant for roadway improvements on Pfeiffer Road; and

**WHEREAS**, the City of Montgomery will, under the terms of a Letter of Offer from the Ohio Department of Transportation, apply for a \$200,000 Jobs and Commerce Grant for the related Ohio National Financial Roadwork Project.

**NOW THEREFORE, BE IT RESOLVED** by the Council of the City of Montgomery, Ohio, that:

**SECTION 1.** The City Manager is hereby authorized and directed to file appropriate applications with the Ohio Development Services Agency and JobsOhio for a 2014 Roadwork Development (629) Grant to support Pfeiffer Road improvements and with the Ohio Department of Transportation for a 2014 Jobs and Commerce Grant for the related Ohio National Financial Roadwork Project.

**SECTION 2.** The Council for the City of Montgomery does hereby endorse and support the applications for such grants for 2014 roadway improvements within the City.

**SECTION 3.** If Ohio Development Services Agency and JobsOhio and Ohio Department of Transportation funds are awarded, the City Manager is authorized to execute all contracts and other documents necessary to implement such program.

**SECTION 4.** The City of Montgomery hereby requests the Ohio Development Services Agency and JobsOhio and also Ohio Department of Transportation to consider and fund these applications.

**SECTION 5.** This Resolution shall be in full force and effect from and after its passage.
